## ADDENDUM A

### **LMU CAST/CREW and COMMUNITY AGREEMENT**

- SFTV sets must be work places free of discrimination of all types and of abusive, offensive or harassing behavior.
- SFTV has a SAFETY HOTLINE: (310) 258-2686 where you or any cast/crew member have the responsibility to report behavior or instances that may be deemed unsafe, violate our policies for Production and COVID or do not hold to this tenet.

#### **COVID Specific**

As we continue to navigate the ups and downs of COVID-19 and related Variant regional case numbers, severity, we ask all projects to take extra care not just by following the required safety protocols on set but also when you are off set. Even if fully vaccinated, as most of us will be, it is essential that ALL SFTV cast/crew members – whether LMU students or not, agree to safe practices off-set. On-Set guidelines in conjunction with safe COVID practices in between productions – especially 5 days before entering any set during our fall production season.

- Wear a mask to keep your nose and mouth covered when you are in shared spaces outside of your home OR with anyone not a part of your household.
- Take care to wash your hands periodically, avoid contact with your face.
- Please AVOID CLOSE CONTACT WITH THOSE OUTSIDE YOUR HOUSEHOLD.
- Avoid high-risk activities such as large gatherings, especially those that do not require vaccination status or that do not require masking.

#### ALWAYS

- honor your commitment to work all agreed upon days
- arrive on time and ready to work
- work as directed until “wrap” is called or 12 work hours have elapsed.
- Stay updated on the Call Sheet instructions.
