

## LION HEALTH CHECK (LHS) COVID-19 PRE-SCREENING SYMPTOM TOOL AND HSS ON-SET CHECK-IN PROCESS

## **BEFORE ENTERING SET:**

**ALL PARTICIPANTS** SHOULD COMPLETE THE LION HEALTH CHECK FOR EACH DAY OF FILMING **BEFORE** ARRIVING ON SET. THIS IS FOR BOTH ON AND OFF CAMPUS FILMING.

This document should be attached to all Call Sheets and the Lion Health Check link and on-set Check-in directions should be included on your Call Sheets.

If the Lion Health Check was not completed, the Health Safety Supervisor (HSS) can conduct the Health Check-In Process by asking the prescreening questions in person. The HSS will also document check-in and check-out dates and times on the <u>Health Check-in Sheet</u>.

The Lion Health Check screening has changed for the Spring '22 semester. It is a prescreening tool **and** is being used to collect VAX and Test Results. It is important that all SFTV cast and crew and non-LMU participants follow the directions below when submitting their Lion Health check.

1. The email you list below will receive the confirmation email clearing your campus access. This is NOT approval to come to campus. Approval for campus access comes from Interim Dean Alexander's office. Be sure to add **SFTV Film Shoot** to describe your activity.

- Indoor performances of any kind
- Exhibition halls and indoor gallery exhibits
- Indoor athletics competitions and events (including basketball games)
- Membership to Burns Recreation Center
- Indoor events with external guests serving food or beverages
- Indoor fitness classes
- Outdoor events with 5,000 9,999 guests

You may also provide proof of your vaccination record if you are a repeat visitor on campus, and you would like Lion Health Check clearance valid through February 28, 2022.



5. When you are cleared by Lion Health Check, you will receive an email with a Green Checkmark. (See image below) All participants will show their Green Checkmark to the HSS when they arrive on set for easy check-in. The HSS will note your arrival and departure times on the Health Check-in sheets. The Health Check-in sheets are used for contact tracing in the event we have a positive case on set.



Thank you – you have been cleared by the Lion Health Check. Please note that Lion Health Check clearance is not a substitute for campus access. Only those individuals who are also approved for campus access will be permitted to enter campus.

Regardless of your COVID-19 vaccination status, face masks are required indoors and recommended in crowded outdoor conditions.
